This inefficient process resulted in limited visibility into supplier performance, poor collaboration and an inability to ensure compliance with both local regulations and Autoliv's high standards. Additionally, their legacy system lacked real-time communication, causing significant delays between audits and supplier feedback. This slow exchange of information had a direct negative impact on parts delivery and procurement, as critical supplier status updates were not relayed to the purchasing team in a timely manner.
